#### **RULES AND REGULATIONS**

- 1. This is an IBCA sanctioned Bar-B-Que cook-off, all IBCA rules apply.
- 2. Contestant may begin checking in Friday September 30<sup>th</sup> from 10 am to 9 pm. Deadline for entering the contest 9 pm September 30<sup>th</sup>, 2016. No more than one (1) team per pit.
- 3. No pre-seasoning or pre-cooking of the meat is allowed until it has been inspected and approved for cook-off use. Once meat has been inspected and approved it must not leave your contest area.
- 4. CATEGORIES TURN IN TIME

Saturday, October 1st

**BEANS** – Dried Pinto Beans must be cooked on location 12:00 pm

**CHICKEN** – 1:00 pm

RIBS – (pork spare ribs only) 2:30 pm

BRISKET - 4:00 pm

- 5. Cooks meeting will be held at 9 am October 1, 2016 Head cook must attend meeting. Turn in containers will be handed out at meeting.
- 6. No sauces or garnishes may be added to judging container. Sauce may be used as mop during cooking but not poured on for presentation.
- 7. All fires used to prepare meat in this contest must be of wood or charcoal. No gas or electric cooking equipment will be allowed (except for beans competition). You may use propane to start your fire. No fires on the ground, or dug pits permitted.
- 8. All entries must be prepared in as sanitary manner as is possible.
- 9. Chief cooks will be responsible for the conduct of his/her team and guest. The excessive use of alcoholic beverages shall be grounds for disqualification. Under no circumstances are alcoholic beverages to be sold, or offered in any form to the general public. NO DISPLAY OF ALCOHOLIC BEVERAGE CONTAINERS WILL BE ALLOWED.
- 10. It is the responsibility of the Bar-B-Que Team to see that the contest area is kept clean, and that the area is cleaned following the contest.
- 11. Excessively loud amplified music or public address system are prohibited.
- 12. Quiet time is 11:00 pm.
- 13. Decision of committee chairman and judges is final.
- 14. The committee chairman reserves the right to make additional regulations as situation warrants.
- 15. VFW Post 8905, Weiser Air Park, Cypress Masonic Lodge 1423, Avon Walk for Breast Cancer, Reach Unlimited, or any one associated with the cook-off will not be responsible for theft, or damage to equipment, or bodily injury of any kind.

#### LOCATION OF COOK-OFF

The cook-off will be held at VFW Post 8905, 21902 Hempstead & Weiser Air Park, 21904 Northwest Freeway (Hwy 290) Cypress, Texas. There will be electricity available for first 20 teams to register. Generators will be permitted but must have quite muffler. Bathrooms will available for teams and public use.
