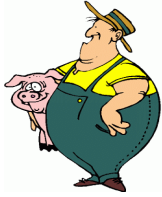
If you prefer, you are allowed to cook near your RV, but you cannot take up more than one space if you are using hookups. RV spots will be at a premium, so it is unfair to others to allow you to spread out unless you choose to be in the pasture area or up front/parking lot hook-ups. FGC donated an RV dump to the EXPO center that is available this year.

Each team is allowed 5 armbands for cooking members. Additional ones can be purchased, but we cannot allow each team to “invite” all friends and relatives under the title “team members”. This is a fund raiser. They are certainly welcome and we want them there, but...

IBCA rules are followed in full for judging. They can be found on the IBCA webpage. As noted above, there is a cooks meeting Friday night to discuss rules and any changes that might have come about since the last cook-off you attended. We would like to ask each team to supply a judge for each of the meats if possible as a large cook off requires lots of judges.

For the safety of everyone, each team is allowed ONE (1) parking permit per team *to come and go in the back*. You may certainly park several vehicles near your pit and not come and go. Parking up front is free at all times.

Chili will be judged for money & a trophy on Friday night. If you are cooking chili please make enough to “share” with our public. The winning chili team will be allowed to pick the “First Responder – (Law Enforcement, Fire Department, EMS group) to receive donation from Friends of Grimes County. First place will receive 50% of chili entry fees.
