

FGC paid out \$11,500 to cookers in prize money in 2016. The more teams entering, the more money!

All returning teams that pre-register <u>no later than one week prior to the event</u> will be allowed to have their previous spot (under the pavilion and/or RV location). We make every effort to put you near your buds, but new teams will be placed on a first come basis after returning teams.

If you prefer, you are allowed to cook near your RV, but you <u>cannot</u> take up more than one space if you are using hookups. RV spots are at a premium, so it is unfair to others to allow you to spread out unless you choose to be in the pasture area or up front/parking lot hook-ups. FGC donated an RV dump to the EXPO center that is available. Any teams found dumping RV wastes in our pasture will NOT be allowed to return.

Each team is allowed 5 armbands maximum for *cooking members*. Additional ones can be purchased, but we cannot allow each team to "invite" all friends and relatives under the title "team members". This is a fund raiser. They are certainly welcome and we want them there, but...(let common sense prevail!)

IBCA rules are followed in full for judging. They can be found on the IBCA webpage. As noted above, there is a cooks meeting Friday night to discuss rules and any changes that might have come about since the last cook-off you attended. We would like to ask each team to supply a judge for each of the meats if possible as a large cook off requires lots of judges (but not a team member). Pelleted pits are allowed. Local Brisket is considered an open item and can be from same brisket. Would like judges of non-local teams to judge the "local brisket".

For the safety of everyone, each team is allowed ONE (1) parking permit per team *to come and go in the back*. You may certainly park several vehicles near your pit and not come and go. Parking up front is free at all times.

We had to pay extra to clean up the horrible mess left by cookers in 2016. Please be good enough to use our dumpster or take your trash home. Do not leave on the grounds. Animals open sacks & it is horrible.

Please help us help everyone make this a great event. If anything seems a problem – let us know in advance – not after the event. All constructive critiques are appreciated and considered.
