**Listed are a set of rules and regulations that are in ADDITION to the rules of The IBCA**

ALL TRASH MUST BE TAKEN TO DUMPSTERS BY THE TEAM. NO TRASH SHOULD ACCUMULATE IN ANY PILES AROUND YOUR AREA. YOUR SITE MUST BE KEPT CLEAN AND SANITARY AT ALL TIMES.

1. Fires must be wood or charcoal. Pit may include gas and electricity to start natural substance.
2. No pit area should be allowed to project beyond their assigned space and teams are not allowed to take contents of their booth out of the assigned space. Including the distribution of literature or material. Props trailers motor homes tents and any other equipment may not exceed the boundary of the contestant's assigned space.
3. All outdoor tents must be secured and anchored.
4. All teams, their agents or employees, shall be responsible for any injury or damage to the grounds of the facilities or equipment of other teams.
5. No extra vehicles will be allowed in the competition area once the pit is set up. Motor home is considered one vehicle. No bicycles, skateboards, rollerblades, ATV's, golf carts or battery powered vehicles allowed with the exception of guests with disabilities.
6. It is the responsibility of the contestant to see that the contest area is kept clean and that the area is cleaned and cleared after contest.
7. All fires must be put out and all building materials and props must be hauled away and equipment removed from site.
8. Excessive use of alcoholic beverages may be grounds for disqualification. TABC rules must be followed. Under no circumstances are alcoholic beverages to be distributed or sold to the general public.

**No glass containers or bottles are allowed on the premises of TEXAS TWISTED TAVERN.**

9. Promoter and cook officials will not be held responsible for accidents, theft, or any mishaps.
10. restrooms and water are available. No electrical hook-ups are available. Generators are allowed.
11. No excessive or loud music allowed. Quiet time will be from 12:00 pm to 7:00 am. Generators will be allowed to operate during quiet time.
12. Spawniac Cookers Officials reserve the right to adjust or make booth assignments up to and including the date of move-in.
13. No food, drinks, or products may be sold without the express written consent of the Spawniac Cookers Committee.
14. Entry fees are non-refundable. Cook off will not be cancelled due to inclement weather.
15. This agreement shall not be assigned, and no rights granted to the team in this agreement shall be subcontracted without the written consent of the Rock the River Committee.
16. No ground pits will be used and all burn down barrels will have a safety barrier placed across the top or around the barrel.
