1. Entry Fee is \$140 per team (includes Pit Space), when received prior to July 31, 2015. Entry Fees are \$150 received on or after August 1, 2015. It would be appreciated if each team would provide one (1) whole cooked ready-to-serve beef brisket to the cook-off committee for selling to the public by 10:00am Saturday August 8th 2015, but this is not mandatory.
 2. Saturday Categories: ½ Chicken, Pork Spare Ribs, and. Beef Brisket.
 3. Awards: Cash Prizes and Trophies will be awarded in each meat category for 1st, 2nd and 3rd Places, as well as the Grand and Reserve Grand Prizes.
 4. Entry Fee for Friday Night OPEN Category Contest is \$10.00, 50% Payback and Trophy for 1st Place.
 5. Entry Fee for Friday Night Dessert Contest is \$10.00, 50% Payback and Trophy for 1st Place.
 6. Entry Fee for Friday Night Pina Colada Contest is \$10.00, 50% Payback and Trophy for 1st Place.
 7. Pit spaces will be assigned as you arrive. Motor Homes or Camper spaces with electrical and water hookups are available for \$15 a night, payable directly to Elk's Lodge - 409-866-4318.
 8. Check in time Friday, August 7th 2015 after 10:00am
 9. Meat Inspection: At arrival meat will be inspected. Cooks meeting at 5:30 pm on Friday. May start prep after inspection.
 10. Friday Judging Times will begin at:
 - a. 7:00 PM OPEN Category
 - b. 8:00 PM Dessert
 - c. 9:00 PM Pina Colada
 11. Saturday Judging Times will begin at:
 - d. 12:00 PM Chicken
 - e. 1:00 PM Pork Spare Ribs
 - f. 2:00 PM Beef Brisket
 - g. 3:00 PM Awards
 12. NO pre-cooking or pre-seasoning of meats is allowed prior to inspection.
 13. NO gas or electric cookers are allowed and NO dug pits.
 14. Fuel for cooking must be of wood or wood substance.
 15. Heat shields must be provided for cookers that are capable of damaging the contest area.
 16. Stable Spirit or Elk's Lodge will NOT be responsible for accidents, theft, or damage.
 17. The Chief Cook will be responsible for the conduct of his/her team.
 18. It is the responsibility of each team to see that the contest area is cleaned and maintained during the contest and that grease is disposed of properly.
 19. Cook-off contestants will observe all rules and regulations of the Stable Spirit BBQ Cook-off.
 20. At a minimum each team MUST purchase a case of beer for a \$35 fee from the Elk's Lodge. Do NOT openly display alcoholic beverages.
