RELEASE AND INDEMNITY AGREEMENT

In consideration of the cook-off contest team identified on this entry form ("Team") being allowed to participate in the specified above contest ("Contest") the Team and I hereby agree: 1) that each Team member or participant will sign and deliver to the BCPSC, the Release and Indemnity Agreement. 2) That BCPSC shall not be responsible for any injury to the Team members, participants, or their guests. 3) That the Team, its members and participants waive any claims, which the Team may have against BCPSC as a result of the operation of the contest. 4) That the Team, its members and participants indemnifies BCPSC against all liabilities including, without limitation, claims, suits and / or judgments, together with the cost of defense of any such claim, suit or judgment asserted against BCPSC as a result of the Team action; or the actions of its members, participants or guests. 5) That the Chief Cook and each Team member, or participants of the Team have read the rules and regulations, which shall govern the contest and the Team, its members and participants, shall abide by such rules and regulations. 6) That any dispute arising from participation in the contest has exclusive and mandatory jurisdiction and venue in Brazoria County, Texas.
