# Gifts of Hope, Inc.

## PURPOSE:

The Gifts of Hope, Inc. is designed to assist with needs of patients at Allison Cancer Center and West Texas Cancer Center. Money is raised through donations, memorials and honorariums which are tax deductible. As donations are made, acknowledgements are mailed to the honored person or family, and a letter of receipt is sent to the donor. The money received is strictly used for direct patient's needs associated with cancer treatment in our communities.

## PROCEDURES:

- 1) Donated funds are guided by the Board of Directors and the Patient Counselor. All requests must be approved by the Patient Counselor before payment of services are made.
- 2) Requests are assessed individually and for patients undergoing treatment at either cancer center.
- 3) Patients and families may reimburse the Gifts of Hope, Inc. if they choose; however, this is not expected. The reimbursement will be assessed as a donation.
- 4) Donations will not be used for premiums, co-pays (except on medications), or bills to the cancer center.
- 5) Community Resources will be referred to the patient and family as well.
- 6) If the Patient Counselor is out of contact area, the Practice Administrator may authorize use of the Gifts of Hope, Inc. fund according to the policy and procedures outlined above.
