Junior Achievement of Acadiana is proud to announce the inaugural **Crazy Cajun Cookoff** to take place October 24 and 25, 2014 at the UL Lafayette Cajun Field RV Parking Lot, Lafayette, LA. BBQ teams are invited from all over the state of Louisiana and beyond and will compete for cash and prizes at this event sanctioned by the [International Barbeque Cookers Association](#) (IBCA).

Junior Achievement of Acadiana invites you and your team to compete in our “cooker friendly” event. Our goal is to provide you, the BBQ team, with a great experience, a well-organized event and a fun time. In addition to the fantastic Cookoff, there will also be children’s activities, live music and entertainment, and an exhibition area for local businesses related to the BBQ / Outdoor Cooking theme.

At the **Crazy Cajun Cookoff**, categories for competition include brisket, pork spare ribs, chicken, and Cook’s Choice (No desserts). In addition to the food categories, there will also be an “Acadiana Champion’s Trophy” given to the local team with the most points. (Must reside in the nine parish area of **Junior Achievement of Acadiana’s** programming coverage. Namely Acadia, Allen, Evangeline, Iberia, Jefferson Davis, Lafayette, St. Landry, St. Martin, and Vermillion parishes.) **At least \$3,000 in cash plus additional prizes will be given away** during the event with payouts for first through tenth places in all major categories (brisket, pork spare ribs, chicken) and top three in the Jackpot “Cook’s Choice” entry.

Crazy Cajun Cookoff® - Rules & Regulations & Entry Form

1. Teams will consist of a Head Cook and up to four (4) team members (total of five). Cooks meeting will be held Friday evening at 6:00 pm in the judging area. HEAD COOKS MUST ATTEND. All teams must check-in at that time. Teams will be allowed on premises beginning at 8:00 am on the Friday of the event. Teams must vacate no later than 11:00 am on the Sunday of the event.
2. IBCA Judging rules will apply.
 - A. Chicken 1 Half fully jointed domestic chicken with skin on (breast, wing with tip, thigh, & drumstick) No Cornish Game Hens.
 - B. Pork Spare Ribs 7 Individual cut ribs (bone-in) (Minimum)
 - C. Brisket 7 Full slices -approx. 1/4" to 3/8" thick (Minimum)
 - D. Cook's Choice Anything but dessert
3. Any and all meat that may be entered into judging will be cooked from scratch within the constraints of the event. Pre-cooking, marinating, etc., will not be allowed either on or off cook-off site prior to the start of the cook-off as defined by the cook-off promoter. Teams must provide their own meat.
4. Cooks are to prepare and cook in as sanitary manner as possible. Cooking conditions are subject to inspection by judging committee. Infractions identified by the judging committee shall be immediately corrected or the cook will be subject to disqualification.
5. Fires must be wood or charcoal. Pit may include gas or electricity to start natural substance. (Not for full cooking.) Holes or open pits are not allowed. Fires may not be built on the ground. Each team must bring a fire extinguisher. No fires are allowed using any type of treated wood or lumber. No railroad crossties, utility poles or treated lumber allowed.
6. TURN IN TIMES:
 - Jackpot – Cook's Choice – Friday, October 24th at 7:00 pm
 - Chicken – Saturday, October 25th – 11:00 am
 - Pork Spareribs – Saturday, October 25th - TBA
 - Beef Brisket – Saturday, October 25th – TBARemaining Saturday turn in times will be announced at the cooks meeting, Friday night, and will be determined by the number of teams competing.
7. AWARDS Ceremony to start at 5:00pm, Saturday, October 25th.
8. Multiple entries in the same category by the same cook and multiple entries from the same piece of meat will not be allowed.
9. In order to be considered for Grand Champion, Reserve Grand Champion, and Acadiana Champion, teams must compete in and enter all three basic meat categories; chicken, pork spareribs, and beef brisket.
10. No pit area shall be allowed to project beyond their assigned space, and teams are not allowed to take contents of the booth out of the assigned space, including the distribution of literature or materials. Props, trailers, motor homes, tents

and any other equipment may not exceed the boundary of the contestants' assigned space. Only one (1) team allowed per space, with a maximum of one vehicle per space.

11. All outdoor tents must be anchored with water barrels or sandbags. Under no circumstance are teams to drill holes or tent stakes in the concrete or asphalt of the premises. If said damage is found to be present, team will be fully responsible for repairing the damages to UL Lafayette's specifications.
12. All teams, their agents or employees shall be responsible for any injury or defacing to the grounds of the facility or the booths or equipment of other teams.
13. No extra vehicles will be allowed in the pit area once the pit is setup. Motor home / trailer / tent trailer is considered one (1) vehicle. No bicycles, skateboards, roller blades, 3 or 4 wheelers, golf carts or battery powered vehicles allowed with the exception of handicapped. (Cook-off officials & security officers are exempt from this rule)
14. It is the responsibility of the contestant to see that the contest area is kept clean & that the area is cleaned and policed following the contest. All fires must be put out, concrete blocks & other building materials or props hauled away & all equipment removed from the site.
15. Excessive use of alcoholic beverages may be grounds for disqualification. Alcoholic beverage rules must be followed. **Under no circumstances are alcoholic beverages to be distributed to the general public.** No glass drinking containers or bottles allowed.
16. Promoter & cook-off officials will not be held responsible for accidents, theft or any mishaps.
17. Handicap restrooms are available. Electricity is available for the first forty registered teams. Site water is available in one location, accessible to all teams. **Generators are allowed.**
18. No excessive or loud music allowed.
19. "QUIET TIME" will be 12:00 AM to 7:00 AM. (Generators will be allowed to run during this time.)
20. JA-CCC directors reserve the right to disqualify any team that does not abide by the rules.
21. JA-CCC reserves the right to prohibit any team, Exhibit or proposed Exhibit, which in JA-CCC's opinion is not suitable for JA's Crazy Cajun Cookoff event. This express reservation concerns persons, items, printed matter, conduct, and all other things which affect the character of JA's Crazy Cajun Cookoff event.
22. JA-CCC reserves the right to adjust or make changes in booth assignments, up to and including the date of move in, to ensure an even flow of traffic or to maintain the theme of JA's Crazy Cajun Cookoff event.
23. No fund-raising activities will be allowed in the booths without express written consent of Junior Achievement of Acadiana. No foods, drinks or products may be sold (unless pre-approved by JA-CCC.)
24. Pit areas which include the operation of audio/visual or lighting equipment must be arranged so that the noise/light from said equipment will not annoy or disturb any contiguous or adjacent teams or attendees.

25. In the event of fire, strikes, rioting, hurricanes, civil disorder, or other circumstances making it impossible to operate the Facility to be determined within the discretion of Junior Achievement of Acadiana, this Agreement shall become null and void. A full refund of deposit will be made or at the option of the team will be transferred towards the cost of future events.
26. This Agreement shall not be assigned and no rights granted to the team in this Agreement shall be subcontracted without the written consent of Junior Achievement of Acadiana.
27. This Agreement contains all of the agreements of the parties, and may only be amended in writing by separate document duly executed by both parties.
28. This Agreement is entered into and performable in Lafayette, Louisiana. The appropriate courts of Lafayette Parish shall have exclusive venue over any claims arising out of or related to enforcements or interpretation of this Agreement, or attendance at the Junior Achievement of Acadiana – Crazy Cajun Cookoff event.
