1. **Meats:** All meats will be cooked on-site, without pre-cooking or marinating. Inspection of meat will be done at check in. ***No meat will be allowed to leave the cook-off site after it has been inspected.***
2. **Entries per pit:** Following the IBCA guidelines only (1) entry (**1 chief cook**) will cook on a given pit. It will be the responsibility of the Auxiliary to monitor entries. Multiple entries in the same category by the same cook and multiple entries from the same piece of meat **shall not** be allowed. Contestants must be 18 years of age to participate for cash prizes.
3. **BBQ Pits:** The following will be allowed
Pit: Any commercial or homemade, trailered or untrailered, pit or smoker normally used for competitive barbeque. Fires shall be of wood, wood pellets or charcoal. A BBQ Pit may include gas or electricity for starting the combustion of wood or wood products **ONLY**.
Back Yard Cooker: Any cooking device by design or nature that is inherently portable and by design is intended for recreational cooking.
4. **Categories:**
 - **Beef Brisket (9 full slices)**
 - **Pork Spare Ribs (9 individual ribs)**
 - **Chicken (2 fully jointed halves w/wing and wing tip)**
 - **Jackpot Chef's Choice \$25.00** (No desert, 1/2 chicken, sliced brisket, or Pork Spare Ribs)
 - **Jackpot Dessert \$25.00** (Must be prepared and cooked on-site)

****Jackpot categories will be 100% payback for 20 or less entries. For over 20 entries 10% will be given to the Auxiliary Charities.*
5. **Judging Trays:** All judging containers shall be clean and free of any markings. *Marked containers may be disqualified at the Head Judge's discretion. Cooks are responsible for insuring that the containers they receive remain clean and undamaged.*
 - **Judging Tray Contents:** The Head Judge will advise all cooks of the exact quantities and cuts of meats that will be placed in the judging trays. This will normally be accomplished at the cook's meeting. The Head Judge or designated representative will inspect all trays at the time of turn-in in order to assure compliance with the turn-in criteria. All garnishes and condiments are prohibited, as they do not reflect true quality of the cooked meats. **Meats may be cooked with sauces and/or other liquids, but once the cooking is complete, sauces, seasonings and/or liquids may not be added once put into the tray. There must be NO PUDDLING OR**

POOLING in the bottom of the tray. Additionally, CONTAINERS THAT CANNNOT BE CLOSED WILL NOT BE ACCEPTED AT TURN-IN.

6. **Turn in Time:** Turn in times are as follows. A turn in window of ten (10) minutes before and after the set turn in times will be recognized. Judging trays received after that time will not be accepted or judging. In the event of any emergency the Head Judge has the authority to make a time change with proper notification to the cookers.

- **Jackpot Dessert: 10:00 am**
- **Jackpot Chef's Choice: 11:00am**
- **Chicken: 12:00 pm**
- **Pork Spare Ribs: 1:300 pm**
- **Brisket: 3:00 pm**

7. **Prizes:** Pay out will be to top 3 in each meat category.

The registration fee of \$170.00 will be split \$50 to the Auxiliary \$20.00 to IBCA, and \$100.00 to the cash pay out. The more teams, the bigger the payout so spread the word!

8. **Players Pool:** Entry to the Players pool is \$50.00. 100% Payback in the 3 main meat catagories. Every team has the opportunity to purchase Paying 1,2,3 in each meat themselves. If you do not want to participate another team has the opportunity to do so at a first come first serve basis. The cut off time to decide is 12:00 Noon on Saturday April 7, 2018.

9. You are more than welcome to sit on our patio with us or utilize our private bar.

10. **CHIEF COOKS MEETING FRIDAY APRIL 6, 2018 7PM!**
