Rules & Guidelines

- 1. A contestant or team consists of one chief cook and no more than four assistants. Contestants may check into the barbeque cook-off grounds beginning Friday, June 15th, at 10:00am until 8:00pm and they must be in place by 8:00am on Saturday, June 16th. Overnight camping is only allowed on Friday and Saturday nights.
- 2. Entry fees are \$150. Entry fee covers all meat categories. \$150 entry fee does NOT cover jackpot chef's choice or jackpot bean entries.
- 3. Categories for the 2nd Annual CPL Mark R. Goyet Memorial BBQ Cook-off are:
 - a. Beef Brisket Turn in approximately 9 slices.
 - b. Chicken (No Cornish Game Hens) Turn in two halves of a fully jointed chicken (half must include leg, thigh, wing, and breast portion).
 - c. Pork Spare Ribs (SLAB) (No Country style, baby back, or loin back) Turn in approximately 9 full ribs, cut apart.
 - d. Quantities for above entries may change based on number of teams.
- 4. Please refer to www.ibcabbq.org for all official rules.
- 5. The Head Cook for each team will be responsible for the conduct of his team, guests, or invitees. As well, the Head Cook will be responsible for his team's compliance with the rules and regulations herein set forth. **EXCESSIVE** use of alcoholic beverages will be grounds for disqualification. Contestants must not give, offer, sell, or donate alcoholic beverages to the general public. Teams will not offer barbecue for **SALE**. Any offensive conduct will be grounds for disqualification from the Cook-off and expulsion from the Barbecue Cook-off Grounds.
- 6. Any nudity, lewdness, or any form of vulgarity will **NOT** be allowed. No pyrotechnics or explosives are allowed. Any intentional use of the above by the team will result in disqualification, and removal from the grounds.
- 7. Music within your team area is allowed. HOWEVER, NO excessive loud music and/or sounds which interfere with announcements, schedules, live bands, and entertainment on stage, or which intrude upon or interfere with the comfort of fellow contestants. This will NOT BE ALLOWED OR

TOLERATED. Offenders will receive ONE warning from either the BBQ Committee and non-compliance will be grounds for disqualification from the Cook-off and expulsion from the grounds.

- 8. Decisions of the CPL Mark R. Goyet Memorial BBQ Cook-off Committee and Judges of the contest are final.
- 9. Cook-off Chairman and CPL Mark R. Goyet Memorial BBQ Cook-off Committee are able to make additional rules and regulations as the situations warrant. All decisions of the Cook-off Chairman and Committee are final.
- 10. Animal(s) of any kind **WILL NOT BE PERMITTED** in any contestant's contest space, nor will any animal(s) be permitted on the Barbeque Cook-off Grounds, **EXCEPT** for animals covered under the Americans with Disabilities Act.
- 11. Trophies will be given to 1st 3rd places in each of the categories and Grand Champion & Reserve Grand Champion overall. Cash prizes for 1st 3rd places in each meat category, jackpot chef's choice, jackpot beans, and the showmanship award.
- 12. Damages/Security/Safety: Teams participating in the contest must not damage in any way the premises on which the contest is being conducted. **UNDER NO CIRCUMSTANCES** are there to be any stakes driven into the asphalt/concrete or any open fires on the grounds. *All fires must be contained in a fireproof container*. *All drippings from BBQ pit must be contained*. Please be sure to bag and dispose of trash properly. Security and safety are the sole responsibility of each team/contestant. The CPL Mark R. Goyet Memorial BBQ Cook-off Committee is not responsible for theft or damage to the property of a contestant, it's members, or its guests. Furthermore, the Committee is not responsible for any injury to any such person(s).
- 13. Each team is responsible for ensuring that its space is cleaned following the contest. All trash must be placed in the dumpster provided. All flames and hot coals must be exterminated and disposed of properly. A team may be disqualified from further participation in the contest or any subsequent contest in the events that the team either causes damage to the grounds or leaves its space in disarray or with loose bundles trash or garbage following the contest.
