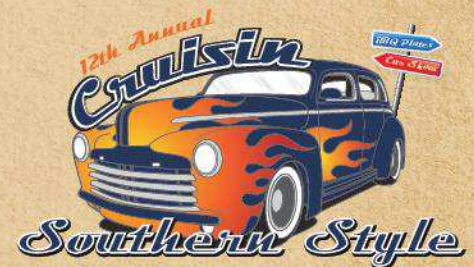

Cook-Off Rules: 11/17/18

1. This is an I.B.C.A. sanctioned event and all rules will apply. To read the IBCA rules please follow this link: <http://ibcabbq.org/wp-content/uploads/IBCA-Rules-Sept-2018-Final.pdf>
2. Only one (1) team per pit. Each team will consist of a Chief Cook and up to four (4) team members.
3. Team Check-in will begin on Friday, 11/16/17 @ 5:00 p.m. in the Judge's Area/RV Lodge. Be sure to verify all categories you are entering at this time. Teams will be allowed to leave within 2 hours after the completion of judging. All non-reserved sites must be vacated by, no later than 6:00 pm, on Sunday night.
4. All meats must be cooked on site. No pre-cooking or marinating, of meats, will be allowed. No meats will be allowed to leave the site after check-in.
5. Fires must be of wood or charcoal. A pit is defined as "any commercial or homemade, trailered or untrailered, pit or smoker normally used for competitive BBQ". The pit may include gas or electricity, for starting the wood and/or charcoal fire, but shall **NOT** be used during cooking.
6. To qualify for the Overall "Traveling Trophy" – you must enter all 3 meats and sauce category.

7. Turn-Ins/Times will be as follows: (Saturday times may be adjusted depending on number of teams)
Friday, November 16, 2018

Dessert, Margaritas, & Soup/Gumbo: 7:30 p.m.

Saturday, November 17, 2018

Sauce: 11:00 AM

KIDS QUE: 11:00 AM Age 5-16, turn-in 2 bone-in pork chops. ****Adult Supervision Only****

12:00 Chicken Turn In (2 chicken halves complete w/wingtip)

1:30 Pork Spare Ribs (9 individual pork spare ribs)

3:00 Brisket (9 Full Slices)

(Standard Turn-In Times Apply Up To 75 Teams)

8. For non-RV spots: Only one (1) vehicle is allowed, per site, and the vehicle will be allowed to leave the area once the site is set-up but may not exit and enter throughout competition.
9. Promoter and/or Cook-Off officials will not be held responsible for accidents, theft, or any mishaps to property or any personal items.

Sauce: Sauce (made by contestant) does not have to be prepared on site. A 16-oz cup will be provided.

Soup/Gumbo: Must be prepared on site. A 16-oz cup will be provided.

Dessert: **HOMEMADE** - Prepare enough for one Styrofoam closed-lid container to turn into judges.

Margaritas: Prepare enough margarita to fill a 16-oz cup that will be provided to you. Each judge will taste the individual margaritas in a sample cup.
