Rules & Regulations

The North Texas Fair & Rodeo Cook-Off welcomes you to the 2nd Annual Cook-Off sanctioned by the International Barbeque Cookers Association. Your participation in this event is sincerely appreciated. We understand that cooking is serious business, therefore our goal is to create a fun, successful and positive event that is rewarding to everyone involved.

EARLY SET UP Thursday, Nov 29 at 12pm. Sites are first come, first served. Hook ups with Electricity are \$20.00 per night. Few sites are full hook ups, therefore it is suggested that ALL TEAMS COME PREPARED TO BE SELF-SUFFICIENT (generator, water) for the duration of the cook-off. The location address is: North Texas Fair & Rodeo 2217 N. Carroll Blvd Denton, Texas 76201. Teams will be directed upon arrival to the area designated for barbeque cooks.

REGULAR SET UP Friday, Nov. 30 at 9:00am. Onsite restrooms are available, but no shower facilities.

CHECK IN Begins on Friday at 3pm.

ENTRY FEES See entry form. Teams must be paid in full before getting turn in trays. No exceptions will be made. There will be no refunds of entry fees for any reason. All team members shall sign a NTF&R Hold Harmless Release Form.

IBCA COOKS MEETING will be held on Friday, Nov 30 at 8:30pm. This meeting is **MANDATORY**.

HEAD COOK will be responsible for the conduct of his/her team & guests. It is expected that teams & guests exercise good sportsmanship at all times. Excessive alcohol consumption and aggressive behavior will not be tolerated. Under no circumstances are alcoholic beverages to be sold, nor are they to be provided to anyone under the age of 21. Uniformed security will be allowed in all areas of the cook-off & will have the authority to handle matters in accordance with the law. Violations may be grounds for disqualification.

QUIET TIME will be strictly enforced beginning at 11:00pm on Friday night. The location is neighborhood sensitive, therefore no loud music, bands, DJ's, karaoke machines, or amplifiers may be used after this time. Violators may be subject to disqualification.

PROHIBITED ITEMS include open carry firearms, fireworks, or explosive devices; unleashed and/or aggressive pets; absolutely NO PUBLIC OR PRIVATE GOLF CARTS or ATV's of any kind except for use by Committee members of the cook-off. Motorized wheelchairs & mobility scooters are allowed only for those who are in need of such devices.

BBQ AWARDS will be held at Fair Hall at approximately 5:00pm on Saturday. Cooking teams are required to have a representative present & claim tickets should be readily available.

CLEAN UP & SAFETY Each team is required to have a working fire extinguisher. Teams are responsible for keeping their cooking sites clean. Bagged trash should be disposed of in the receptacles provided **during & after** the cook-off. Please ensure your area is free of debris upon your departure. Sites should be left in the same condition as they were found upon your arrival.

EXIT All teams, vehicles, trailers, & equipment must be off the premises by 5pm Sunday, Dec 2, 2018.

PRACTICE PARTICIPANT RELEASE AND INDEMNIFICATION AGREEMENT

_____, hereinafter referred to as "Participant", is executing this document voluntarily or, if participant is a minor, **has his/her**, hereinafter referred to as "his", **Parent or Guardian's**, hereinafter referred to as "Guardian", **express permission to participate in sporting event on the North Texas State Fairgrounds**. Participant/ Guardian states that participant has consideration of him being allowed to participate and/or practice he agrees as follows:

1. **PARTICIPANT/GUARDIAN AGREES TO INDEMNIFY AND HOLD NORTH TEXAS STATE FAIR ASSOCIATION, INC.**, hereinafter referred to as "FAIR", THEIR OFFICERS, DIRECTORS, EMPLOYEES, MEMBERS, AND VOLUNTEERS AND/OR AGENTS **HARMLESS AGAINST ALL CLAIMS, DEMANDS, DAMAGES, COSTS AND EXPENSES**, including reasonable attorney's fees for the defense thereof, arising from Participants', or his guests', or children's activities on or around the North Texas State Fair Association Grounds, hereinafter referred to as "Fair Grounds", at any time, **EVEN IF** the claim, demand, damage, cost or expense is **CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE FAIR.**

2. **PARTICIPANT/GUARDIAN FURTHER RELEASES THE FAIR FROM ALL LIABILITY** THE FAIR may otherwise owe to Participant, his heirs, survivors, beneficiaries, or assigns **FOR ANY PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH**, that Participant suffers while on the Fair Grounds, at any time, including but not limited to first aid, treatment or service rendered participant during participation in any event and/or practice. This release applies to all injuries or damages which may be suffered by Participant, his heirs, survivors, beneficiaries, or assigns, **EVEN IF CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE FAIR.** This liability release also applies to claims and causes of action for injury to or the death of any of Participant's children.

3. **PARTICIPANT/GUARDIAN ACKNOWLEDGES THAT ALL ACTIVITIES, PRACTICE OR SPORTING EVENTS, ON PROPERTY SUCH AS THE FAIR GROUNDS CAN RESULT IN INJURY** or property damage to the person engaged in those activities as well as others. The many possibilities and sources of injury or damage are acknowledged by Participant/ Guardian and Participant comes upon the Fair Grounds will full knowledge of such hazards. Participant/Guardian hereby gives his permission and consent to be transported to a hospital and given treatment by any doctor or hospital and his, her or its personnel.

4. Participant/Guardian has read this document and understands its terms and conditions. Participant/Guardian is signing it freely and voluntarily. Participant/Guardian also releases any photographic image or video image to be used by the Fair as advertising or in promotion of the Fair and other events concerning the North Texas State Fair and Rodeo.
