Cooking 1st through 3rd Place, Cookers Choice (team that best represents the overall

items and best attitude).

Rules and Regulations

- I. Check in time will be from Noon till 6 p.m. on Friday, November 13, 2015. All contestants must be set up before 7 p.m.
- 2. Contestants may not enter contest area before Noon on Friday, November 13, 2015 unless you have a preassigned space. The Head Cooks meeting will be at 6:00 p.m., Friday, November 13, 2015.
- 3. Due to the fact that this is a family event, the cook-off area will be secured at 7:00 p.m., Friday, November 13, 2015. There will be no further vehicle traffic in contest area until 7 a.m. Sunday, November 15, 2015. For teams choosing an early departure, the barricades will be removed immediately following the award ceremony and re-secured at 9:00 p.m. Saturday, November 14, 2015. Please DO NOT move any barricades prior to the awards ceremony ending or after barricades have been put back in place.
- 4. The cook-off committee will provide an approximate size of 30' x 30' space for this cook-off. Props, trailers, motor homes, tents, coverings or any other part of the team's equipment must not exceed boundaries of space assigned. Only one vehicle per team will be allowed in the contest area. Additional vehicles used for unloading supplies/equipment, MUST be unloaded immediately and then REMOVED from contest area and parked OUTSIDE barricades. One warning will be given, 2nd warning will result in 10 points being deducted from overall score, 3rd warning will result in offending team being disqualified. Entry fee is non-refundable. Please be considerate of other teams by not leaving non-essential vehicles in contest area during set up. Extra space does NOT include additional vehicle. There will be no exceptions. In order to secure your previous year space, entry payment and all forms must be received by Friday, October 30, 2015. If payment and forms are not received by due date, space will become open for all entered teams. NO EXCEPTIONS!!!

 This will give us enough time to notify a team that is on the waiting list that a space has come available.
- 5. A team will consist of a chief cook and four assistants. If entering multiple teams, each team must have a different head cook and members.
- 6. Sanctioned category entries will be as follows:

Brisket – seven (7) full slices, ¼ to 3/8 of an inch thick. Chicken – ½ fully jointed chicken (to include breast, wing, thigh and drumstick.) Pork Spare Ribs – seven (7) individual cut ribs (bone-in).

If the even has 50+ teams, turn-in quantities shall be two (2) ½ chickens, 9 pork spare ribs, and 9 slices of brisket shall be submitted for judging or at the Head Judge's discretion.

- 7. Jackpot category entries will be as follows:
 - A. Fajitas Beef only, no garnishing (which includes bell pepper and onions, etc.). No pre-marinated allowed.
 - B. Chili Fine ground beef hamburger meat only, no venison. No fillers, including beans.
 - C. Exotic NO SEAFOOD ALLOWED. This entry may be garnished.
 - D. Seafood This entry may be garnished.
 - E. Turkey May be cooked in any manner you like. May be sliced, include dark and white meat. (No garnishing includes stuffing.)
- 8. All meat may be inspected at check-in or until 10 p.m., Friday, November 13, 2015. Meat may be put on to cook anytime after inspection. Special arrangements may be made for late arrivals.
- 9. No pre-cooked or salted meat is allowed.
- 10. All meat and pits may be inspected by the contest committee persons at any time, and foods may be sampled.
- 11. No gas or electric cooking will be allowed. Exception: Turkey and Chili may be cooked any way or any how you please; as long as it is cooked on site. Remember there is NO garnishing (this includes stuffing in the Turkey and beans in the chili).
- 12. Holes or dug pits are not permitted.
- 13. Contestants must supply all needed equipment and supplies. Cook-off committee will provide space only.
- 14. Judging of all meat will be on the following criteria: color, texture/tenderness, over taste and aftertaste.

 Trophies will be for 1st, 2nd, and 3rd place with overall trophy points awarded for first place through tenth place.

 Total points will determine the winner of the overall.
- 15. Decision of the chairpersons and/or committee is final.
- 16. Any protest of any team or their equipment must be turned into cook-off chairpersons one hour prior to judging.
- 17. Cookers choice award will be announced along with the rest of the awards.
- 18. No loud music will be tolerated. Any speaker systems will be arranged so that the speakers point out the back of the campsite. Two warnings will be given. After that 10 points will be deducted from the overall score.
- 19. All pits must have a drip bucket. Any and all oil used must be placed in the oil dump container provided by the committee.
- 20. Due to shortage of manpower, we are asking each team to dispose of all trash into the provided roll off dumpster.

Gobbler Cook-Off Teams

<u>All</u> Teams will be **REQUIRED** to have one (1) 5 lb. 3A-40BC fire extinguisher. Any team using oil for cooking (deep fryers) will be required to have a 5 lb. 3A-40BC fire extinguisher <u>AND</u> K-Class fire extinguisher which is specifically used on oil/grease cooking fires. <u>Deep frying under a tent or canopy is not allowed.</u> You may cook outside the tent or canopy and within your rented space.

All cook-off teams will be inspected this year. You must be in compliance.

PARKING

This year our participating teams will be given a parking pass to be able to park in the Lake Jackson Recreation Center parking lot. Security / Barricade Rules

Barricades are to remain in place from 7:00 PM Friday, November 13, 2015 until 7:00 AM Sunday, November 15, 2015. There will be NO vehicle traffic in the cookoff area during the secured times. One vehicle is allowed to remain inside barricades per site and must have a car tag. This vehicle is to remain parked once barricades are in place. If any barricade is found down or removed from proper position during the secured times, it was NOT done by the committee. A committee member should be notified immediately and barricade put back in proper position. If barricades are found out of proper position, this DOES NOT mean vehicles are allowed in or out of premises.

Additional vehicles used for set-up/tear down must be unloaded/loaded and removed from cook-off area immediately and parked OUTSIDE the barricaded area.

If an unauthorized vehicle belonging to a cook-off team member or a guest of a cook-off team is found inside the barricades during secured hours, the following will apply:

1st warning is free.

2nd warning will result in 10 points being deducted from the offending teams overall score.

3rd warning will result in disqualification of offending team. Entry fee is non-refundable. Offending team will not be invited back.
