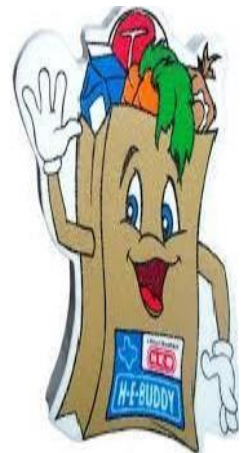

## Pharr BBQ Cook-off Rules and Guidelines:

1. Entry Fee: \$125.00 for one or all meat categories.
2. MANDATORY MEETING: A Head Cooks meeting will take place at 8am in the Judging area Saturday, January 10, 2015
3. COOKED ON SITE: All entries must be prepared and cooked on site.
4. COOK-OFF SITE: A 20' x 20' cook-off site will be provided. Cook-off camp site setup can start on Saturday, January 10, 2015 at 5:00 am. Cook-off site will open at 5:00 am on Saturday, January 10, 2015 for setting up. No water or electricity will be provided on site. All outdoor tents must be anchored with water barrels or sandbags. **Under no circumstance are teams to drill holes or tent stakes in the concrete or asphalt of the premises. If said damage is found to be present, team will be fully responsible for repairing the damages to HEB's specifications.** Tap water will be available at the location. Security will be provided.
5. SANITATION: Cooks are to prepare and cook in a sanitary manner as possible. Cook-Off teams are responsible for keeping the contest area clean of trash.
6. OPEN FIRES: All open fires / fire pits shall have a barrier around it. No ground fires. Teams must have a fire extinguisher readily available.
7. VEHICLE TRAFFIC: All traffic lanes in the contest site must be open at all times. Vehicles will be allowed in cook-off area for drop off and pick up only on Saturday from 5:00 am until 3:00pm. Vehicle traffic access will be closed by 8:00am Saturday. One vehicle will be allowed on site if space allows.
8. JUDGING TRAYS: A Styrofoam tray with hinged lid & foil paper will be provided with double number ticket. All judging containers shall be free of any markings.
9. **Prohibited: No pets, golf carts or ATV's will be allowed on the Cooking grounds. No Alcohol Beverages will be allowed during the event. Due to liability of the promoter/premises.**
11. CATEGORIES - TURN IN TIMES - QUANTITY: **Will be decided by head judge prior to event.**  
The promoter and/or Head Judge will advise all cooks of the exact quantities and cuts of meat that will be placed in the judging trays.  
Recommended amounts are as follows:  
Fajita: approximately one pound  
Beans: 16 oz cup  
Brisket: seven (7) full slices approximately 1/4" to 3/8" thick  
Pork Spare Ribs: seven (7) individual cut ribs (bone-in)  
Chicken: 1/2 fully jointed chicken (to include a breast, wing with tip, thigh, and drumstick, with skin on).
12. TURN-IN TIME — Turn-in times for each category shall be pre-set. Once this time is set and/or announced no changes will be made. A turn-in window often (10) minutes before and after the set turn-in time will be recognized. Judging trays received after that time will not be accepted for judging.
13. JUDGING: All decision of Judges is final. Judging will consider Appearance, Aroma, Texture and Taste.
14. RESPONSIBILITY/ LIABILITY: This is a Family Event. The Head Cook is responsible for the conduct of his/her team members and guests. The HEB Cook-off Committee and volunteers are not responsible or liable for loss of items, damage of property, injury or accidents to any person entered as a contestant or any of the contestant's family members or guests.
15. Prize money / trophies will be given to winners.
