Texas Trophy Hunters Association[™] (TTHA) is proud to announce the fourth annual <u>TTHA's Bucks and</u> <u>BBQ® State Championship BBQ Cook-Off and Food Drive</u> to take place March 7-8, 2014 at the National Shooting Complex in San Antonio. BBQ teams from all over the great state of Texas and beyond will compete for cash and prizes at this **Texas State BBQ Championship** event sanctioned by the <u>International Barbeque Cookers Association</u> (IBCA).



TTHA invites you and your team to compete in our "cooker friendly" event. Our goal is to provide you, the BBQ team, with a great experience, a well-organized event and a fun time. In addition to the fantastic Cook-Off, there will also be children's activities, live music, and the opportunity to shoot clay targets or skeet during the National Shooting Complex's Public Shooting Event, which will all take place on Saturday, March 8th.

At TTHA's Bucks & BBQ[®] Cook-Off, the Grand Champion will qualify for the American Royal in Kansas City and Lottery for Jack Daniels. Additionally, each member of every team (up to 5 people per team) signed up in the cook-off will receive a 1-year membership to TTHA (a \$174.75 value.) Categories for competition include brisket, pork spare ribs, chicken, beans and the coveted wild game. In addition to the food categories, there will also be a showmanship award given to the team with the "best set up" in their team space. At least \$7,500 in cash plus additional prizes will be given away during the event with payouts for first through sixth places in all categories (brisket, pork spare ribs, chicken, beans and wild game-open.)

TTHA recognizes that while the BBQ teams compete for fun, glory and prizes, there are many people in the San Antonio area that go hungry every day. Therefore, TTHA has teamed up with the <u>San Antonio Food Bank</u> to raise awareness and



to add a much needed boost to the community pantry. The mission of the San Antonio Food Bank is to fight hunger in Southwest Texas through food distribution, programs, education and advocacy. All teams and attendees at the TTHA's Bucks and BBQ[®] event are asked to bring canned goods, other non-perishable food items and/or monetary donations to the BBQ cook-off event. Collection bins will be on site for donations.

TTHA's Bucks and BBQ® Rules & Regulations

- 1. Teams will consist of a Head Cook and up to four (4) team members (total of five). Cooks meeting will be held Friday evening at 8:00 pm in the judging area. HEAD COOKS MUST ATTEND. All teams must check-in at that time. Teams will be allowed on premises beginning at 7:00 am on the Friday of the event. Teams must vacate no later than 10:00 am on the Sunday of the event.
- 2. Move in time for the event starts on Friday morning at 7:00 am and must be completed by 6:00 pm. Please note that the road will be closed starting at 6:00 pm Friday and will not re-open until after the awards ceremony on Saturday. If you need to make special arrangements regarding move in please call 210-523-8500. Only one vehicle will be allowed in the designated spot (motor home/travel trailer is one (1) vehicle.
- 3. IBCA Judging rules will apply.

A. Chicken	2 Half fully jointed domestic chicken with skin on (breast, wing with tip, thigh, & drumstick) No Cornish Game Hens.
B. Pork Spare Ribs	9 Individual cut ribs (bone-in) (Minimum)
C. Brisket	9 Full slices -approx. 1/4" to 3/8" thick (Minimum)
D. Beans	Pinto Beans – nothing larger than the bean in the cup
E. Wild Game	Venison, Axis, Elk, Dove or Quail – choose one, anything goes!

- 4. Any and all beans, meat and/or meats that may be entered into judging will be cooked from scratch within the constraints of the event. Pre-cooking, marinating, etc., will not be allowed either on or off cook-off site prior to the start of the cook-off as defined by the cook-off promoter. Teams must provide their own meat/beans. Meat inspection will take place at the Bucks and BBQ Check In tent.
- 5. Fires must be wood or charcoal. Pit may include gas or electricity to start natural substance. (Not for full cooking.) Holes or open pits are not allowed. Fires may not be built on the ground. Each team must bring a fire extinguisher. No fires are allowed using any type of treated wood or lumber. No railroad crossties, utility poles or treated lumber allowed.
- 6. No pit area shall be allowed to project beyond their assigned space, and teams are not allowed to take contents of the booth out of the assigned space, including the distribution of literature or materials. Props, trailers, motor homes, tents and any other equipment may not exceed the boundary of the contestants' assigned space. Only one (1) team allowed per space.
- 7. All outdoor tents must be anchored with water barrels or sandbags. Under no circumstance are teams to drill holes or tent stakes in the concrete or asphalt of the premises. If said damage is found to be present, team will be fully responsible for repairing the damages to TTHA's specifications.
- 8. All teams, their agents or employees shall be responsible for any injury or defacing to the grounds of the facility or the booths or equipment of other teams.

- 9. No extra vehicles will be allowed in the pit area once the pit is setup. Motor home is considered one (1) vehicle. No bicycles, skateboards, roller blades, 3 or 4 wheelers, golf carts or battery powered vehicles allowed with the exception of handicapped. (Cook-off officials & security officers are exempt from this rule)
- 10. It is the responsibility of the contestant to see that the contest area is kept clean & that the area is cleaned and policed following the contest. All fires must be put out, concrete blocks & other building materials or props hauled away & all equipment removed from the site.
- Excessive use of alcoholic beverages may be grounds for disqualification. Alcoholic beverage rules must be followed.
 Under no circumstances are alcoholic beverages to be distributed to the general public. No glass drinking containers or bottles allowed.
- 12. Promoter & cook-off officials will not be held responsible for accidents, theft or any mishaps.
- 13. Handicap restrooms & water are available. Water and electricity hookups are available for travel trailers or motor homes. Generators are allowed.
- 14. "QUIET TIME" will be 11:00 PM to 7:00 AM. (Generators will be allowed to run during this time.) NO excessive or loud music allowed.
- 15. TTHA directors reserve the right to disqualify any team that does not abide by the rules.
- 16. TTHA reserves the right to prohibit any team, Exhibit or proposed Exhibit, which in TTHA's opinion is not suitable for TTHA's Bucks & BBQ event. This express reservation concerns persons, items, printed matter, conduct, and all other things which affect the character of TTHA's Bucks & BBQ[®] event.
- 17. TTHA reserves the right to adjust or make changes in booth assignments, up to and including the date of move in, to ensure an even flow of traffic or to maintain the theme of TTHA's Bucks & BBQ event.
- 18. No fund-raising activities will be allowed in the booths without express written consent of TTHA. No foods, drinks or products may be sold (unless pre-approved by TTHA.)
- 19. Pit areas which include the operation of audio/visual or lighting equipment must be arranged so that the noise/light from said equipment will not annoy or disturb any contiguous or adjacent teams or attendees.
- 20. In the event of fire, strikes, rioting, hurricanes, civil disorder, or other circumstances making it impossible to operate the Facility to be determined within the discretion of TTHA, this Agreement shall become null and void. A full refund of deposit will be made or at the option of the team will be transferred towards the cost of future events.
- 21. This Agreement shall not be assigned and no rights granted to the team in this Agreement shall be subcontracted without the written consent of TTHA. This Agreement contains all of the agreements of the parties, and may only be amended in writing by separate document duly executed by both parties.
- 22. This Agreement is entered into and performable in San Antonio, Bexar County, Texas. The appropriate courts of Bexar County shall have exclusive venue over any claims arising out of or related to enforcements or interpretation of this Agreement, or attendance at TTHA's Bucks & BBQ[®] event.
