1. Cooks meeting and Check in will be at 5:30 PM Friday April 25, 2014 at the Cook Team Tent.
2. Meat must be cooked on site, you must have two pork chops (3/4 to 1" Center cut) to turn in to judges.
3. Meat is subject to inspection upon arrival. No meat may be removed from cook-off site after check in.
4. Children must be accompanied by an adult over 18 years of age.
Although assistance from an adult is encouraged, the child must do the cooking and turn in the box which will be provided at the judge's pavilion.
5. Pit Requirements: Commercial or Homemade or smokers using wood or wood products only, NO gas or electric. You may use multiple kids from one site.
6. Turn in time is Friday April 25, 2014 to the judge's pavilion.
7. Prizes will be awarded to 1st place winners in each age group.
