INDEMNIFICATION: In consideration of this team entry and the right to participate in this event, as Head Cook, on behalf of myself and each of the members of my team, I hereby acknowledge there is inherent risk in participating in the 2014 TylerQue Throw Down (the "Event"), beyond the control of High Strung BBQ, ("HSBBQ"); City of Kirby, Texas ("City"); TylerQue Volunteers; City of Kirby Parks & Recreation, the Liles family and each of their respective directors, officers, employees, agents and assigns (collectively, the "Released Parties"), to both participants and the public, and on behalf of myself and each of the members of my team, we voluntarily accept and assume those risks. As Head Cook, I have explained these risks to my team members and we, as a team, accept full and unconditional responsibility for public safety matters in and around our designated area, including safety matters relating to any equipment, displays, advertising/promotional items or objects brought to the Event that may cause injury to the public, a participant or a member of my team, including property damage to any other person's property. As Head Cook, on behalf of myself and each of the members of my team, I hereby indemnify, release, discharge and hold harmless HSBBQ, the City, TylerQue Volunteers, the City of Kirby Parks Recreation, the Liles Family and the other Released Parties from any claims, demands, causes of action, proceedings, fines, penalties, losses, liabilities, damages, costs or expenses (including reasonable attorneys' fees) (collectively, "Liabilities") to which the Released Parties, or any of them, may become subject, arising from or in any way relating to (i) any injury or property damage caused, in whole or in part, by myself or any of the members of my team, including, without limitation, the actual or alleged serving or over serving of alcoholic beverages to any persons (including members of my team); or (ii) my, or any of the members of my team's participation in or attendance at the Event, including all such Liabilities resulting from negligence or any of the other Released Parties. I HEREBY ACKNOWLEDGE AND AGREE THAT THE FOREGOING INDEMNITY AND RELEASE PROVISIONS INCLUDE INDEMNIFICATION AND RELEASE BY THE UNDERSIGNED FROM AND AGAINST THE RELEASED PARTIES' OWN NEGLIGENCE.

As Head Cook, on behalf of myself and each of the members of my team, I hereby further covenant not to commence or prosecute any action, suit or other proceeding against HSBBQ, the City, TylerQue Volunteers, the City of Kirby Parks Recreation, the Liles Family or any of the other Released Parties as a result of any property damage or personal injury incurred at the Event, or otherwise in connection with the foregoing paragraph.

THIS IS A LEGAL DOCUMENT WAIVING VALUABLE RIGHTS. AS HEAD COOK, I ACKNOWLEDGE AND AGREE THAT I HAVE READ AND UNDERSTAND THE TERMS AND CONDITIONS OF THIS RELEASE AND HAVE CONVEYED THE SAME TO EACH OF THE MEMBERS OF MY TEAM BEFORE SIGNING, WHO ALSO HAVE EACH ACKNOWLEDGED AND AGREED THAT THEY HAVE READ AND UNDERSTAND THE TERMS AND CONDITIONS OF THIS RELEASE.
