PLEASE READ CAREFULLY

- 1. BEEF FAJITAS: YOU MUST PROVIDE AT LEAST 12 SLICES OF FAJITA MEAT TO BE TURNED IN FOR JUDGING.
- 2. CHICKEN: YOU MUST TURN IN THE FOLLOWING FOR JUDGING 2 SEPARATE ½ FULLY JOINTED CHICKEN HALVES (TO INCLUDE BREAST, WING, THIGH AND DRUMSTICK).
- 3. PORK RIBS: REMEMBER TO INCLUDE 9 RIBS FOR JUDGING. NO BABY BACK RIBS
- 4. BEEF BRISKET: REMEMBER TO INCLUDE 9 FULL SLICES OF BEEF FOR JUDGING.
- 5. BEANS: MUST TURN IN ½ GALLON OF BEANS FOR JUDGING. PINTO BEANS ONLY.
- 6. ALL TEAMS MUST HAVE OPERATIONAL FIRE EXTINGUISHER ON SITE AT ALL TIMES.
- 7. ONLY ONE CUT MEAT TO BE JUDGED PER CONTESTANT OR TEAM. THAT MEANS TWO TEAMS MAY NOT COOK FROM SAME PIT OR FROM ONE FIREBOX.
- 8. A TEAM CONSIST OF CHIEF COOK AND 3 ASSISTANTS (TOTAL OF 4).
- 9. ALL MEAT WILL BE INSPECTED AT THE TIME YOU CHECK IN.
- 10. CONTESTANTS MUST SUPPLY NEEDED EQUIPMENT AND SUPPLIES. DARYL'S PLACE WILL PROVIDE ONLY THE SPACE. (WE WILL NOT PROVIDE ELECTRICTY OR WATER)
- 11. HOLES OR DUG PITS ARE NOT PERMITTED
- 12. DARYL'S PLACE WILL NOT BE RESPONSIBLE FOR THEFT OR DAMAGE.
- 13. IT IS RESPONSIBILITY OF TEAM TO KEEP CONTEST AREA IS KEPT CLEAN DURING AND AFTER CONTEST.FAILURE TO DO THIS WILL RESULT IN THE TEAM NOT BEING ALLOWED TO ENTER THE FOLLOWING YEAR. (THERE IS A DUMPSTER AT THE BACK OF BUILDING FOR TRASH)
- 14. A 30X30FT SPACE WILL BE PROVIDED FOR EACH TEAM..PROPS, TRAILERS, ETC. MUST<u>NOT</u> EXCEED THE BOUNDARIES OF ASSIGNED SPACE. ONE MOTOR HOME, CAMPER OR VEHICLE IS ALLOWED INSIDE OF SPACE. NO VEHICLES MOTOR HOMES OR TRAILERS CAN BE PARKED IN FRONT OF SPACE.
- 15. EXTRA VEHICLE MUST BE PARKED IN PARKING LOT.
- 16. CONTEST COMMITTEE MEMBERS RESERVE THE RIGHT TO MAKE ADDITIONAL REGULATIONS AS SITUATIONS WARRANT.
- 17. DECISIONS OF COMMITTEE CHAIRMAN AND JUDGES ARE FINAL.
- 18. CHIEF COOK WILL BE HELD RESPOSIBLE FOR CONDUCT OF HIS/HER TEAM AND THEIR GUESTS. EXCESSIVE USE OF ALCOHOL BEVERAGES WILL BE GROUNDS OF DISQUALIFICATION.
- 19. <u>ABSOLUTELY NO OPEN BAR OR OUTSIDE ALCOHOLIC BEVRAGES WILL BE ALLOWED ON PREMISES.</u> BEER, ALCOHOL, WILL BE AVAILABLE FOR SALE BY DARYL'S PLACE TO THE PUBLIC. YOU MAY BRING IN YOUR OWN NON-ALCOHOLIC BEVERAGES
- 20. COOK OFF TEAM WILL BE GIVEN ARM BANDS AND WILL RECEIVE HAPPY HOUR PRICES DURING COOK OFF.
- 21. IF CAUGHT WITH OUTSIDE ALCOHOLIC BEVERAGES YOUR TEAM WILL BE DISQUALIFIED.
- 22. UNDER NO CIRCUMSTANCES WILL CONTESTANTS BLOCK WALK WAY AFTER THE SET UP ON FRIDAY.
- 23. GOLF CARTS, MOTOR VEHICLES, MOTOR CYCLES, ROLLER BLADES/ SKATES, OR ANY TYPE OF TRANSPORTATION(WITH THE EXCEPTION OF WHEEL CHAIRS USED ON PREMISES BY HANDICAPPED INDIVIDUALS) WILL NOT BE ALLOWED IN CONTEST AREA.
